#### The Look I Love

Stick to soft neutrals, earth tones, and muted pastels — think beige, ivory, taupe, sage, dusty blue, blush, rust, and soft gray.

# **Color Palette Suggestions**

I recommend wearing soft, natural tones like warm beige, cream, oatmeal, dusty rose, sage green, terracotta, and muted blues or grays.

These colors photograph beautifully in natural light and complement each other without competing.

# **Tips for Everyone**

Texture > Pattern: Choose flowing fabrics (linen, cotton, chiffon) and subtle textures (knits, lace, embroidery) over bold prints.

Shoes: Neutral, simple footwear (barefoot for beach sessions looks great!). Avoid bright white sneakers or athletic shoes.

Accessories: Think delicate and minimal — dainty jewelry, a wide-brimmed hat, hair bows for kids. Nothing that competes with your face or emotions.

# OUTFIT INSPIRATION BY SESSION TYPE:

## **Family Sessions**

- Overall Look: Coordinated, not matching.
- · Mix and match complementary tones across family members.
- Women/Mom: Flowy midi or maxi dresses in soft, flattering colors. (Think wrap dresses, lace details, or textured neutrals.)
- $\bullet \quad \text{Men/Dad: Simple button-down or henley in muted tones, paired with chinos or soft jeans.}\\$
- Kids: Rompers, knits, overalls, or soft cotton dresses. Think adorable but comfortable.

Pro Tip: Start with mom's outfit and build the family's look around it!

## **Couples + Engagements**

#### Look 1 - Casual Romantic:

- Flowy dress for her (soft florals, solid pastel, or lace)
- Neutral shirt and pants for him (linen, chambray, or a soft tee + chinos)

#### Look 2 - Elevated Classic:

- Long neutral dress or jumpsuit + soft waves or braid
- Neutral blazer, sweater, or button-down for him
- Outfit Changes: Two outfits are great one more dressy, one more casual and cozy (think barefoot on the beach or boots in the woods)
- Barefoot, boots, or sandals depending on location

### **Maternity Sessions**

- Showcase the bump: Choose fitted or flowy gowns that highlight your belly — empire waists or wrap styles are perfect.
- Top Picks: Maxi dresses with movement, off-the-shoulder styles, knits that hug your shape.
- For Partners: Complement your outfit with soft tones no need to match perfectly.
- Optional Add-Ons: Bring a cozy cardigan, shawl, or flower crown for a feminine touch.
- Barefoot or sandals for beach/nature, boots for rustic settings.

## **Bonus Tips**

- Bring a blanket for sitting shots (neutral/earth-toned)
- · Avoid watches, smartwatches, or hair ties on wrists
- Try outfits on before the shoot to ensure comfort and confidence
- Iron or steam clothes beforehand to avoid wrinkles
- Choose outfits that allow you to move freely and comfortably
